






WHERE OUR MONEY WENT IN 2019

In 2019 \$94,212 AUD was forwarded to support our development projects in Myanmar. This represented 76% of donations received and 64% of total expenses.

Of these funds \$11,155 was allocated for the renovation of a house to be used as a Birthing Unit for the Maternal Health Project. Our fundraising target for this project was \$15,000 and the balance will be sent in 2020.





FUNDRAISING

In early 2019 the Committee of Management decided to try to increase the focus on raising funds and the decision was made to employ a full time fundraiser for a period of time. The funds used to cover this expense were not taken from regular donations but from a grant that was held in reserve.

SUMMARY OF PROGRAMS

MATERNAL & CHILD HEALTH (83% of funds sent)

SPM has one permanent volunteer working in a remote area of Myanmar. As a qualified midwife, she co-ordinates the maternal and child health project in partnership with Earth Mission Asia (EMA). As well as running an antenatal clinic **5 days a week** with ultrasound services this program oversees the training and support of local midwives. **772 ultrasounds** were carried out during the year at the antenatal clinic. Having ultrasound technology available in this remote location has meant that any high-risk issues are picked up early. The antenatal clinic referred a total of **27 women** for specialist care and delivery. During 2019 **710 children under 5** were seen at the T-RAD clinic, with an average of 3 children under 5 staying at the in-patient ward each month. This year several pieces of equipment have been purchased: a machine that detects hormone levels, kiwi cups, baby scales and extra parts for an obstetric teaching model. The maternal health program also provides the funds for some of those women needing specialist care and also supplied **6 babies**, who for some reason are unable to be breast fed, with milk powder.

EARLY CHILDHOOD EDUCATION (14% of funds sent)

SPM supports a small grass roots organisation called Community Care Myanmar (CCM) which works in one of Yangon's largest slums. There is no school nearby for the hundreds of children living in the slum to attend, and most of the parents are unable to afford the school fees and transportation costs needed to send them to the closest school. The CCM team runs a preschool class where **29 boys and 26 girls** gather 5 mornings a week for stories, songs, games and a nutritious lunch. Another class made up of **38 older children** gathers for a slightly more formal time of basic reading, writing and math. A further **25 children** who have graduated from the older class are given a scholarship to attend the local school so that their school fees, uniforms, bus fares and stationery are provided. The CCM team also holds regular meetings with the parents to raise awareness on issues such as the importance of education, hygiene, child exploitation and life skills. The team also monitors the health and well being of all of the families associated with the school as well as the wider community and provides support whenever possible.

During 2019 **SPM** was able to help coordinate a growth monitoring program to try and evaluate the effectiveness of the feeding and vitamin supplement program. As this was the first year that the screening took place no longitudinal conclusions could be made. The funds **SPM** sent during 2019 contributed to approximately 40% of CCM's overall budget and an additional \$3,150 was sent to them so that a water pump and bore could be installed at their new school facilities. **SPM** also supports CCM with advice on account keeping and we pay for the registration of their on-line accounting package.

PHYSICIAN ASSISTANT TRAINING (3% of funds sent)

The Physician Assistant Training Program is a 5 year course facilitated by Earth Mission Asia. The goal is to help strengthen the Karen Department of Health and Welfare (KDHW) by providing them with well-trained and highly skilled health professionals. Year 1 students are based in Chang Mai Thailand and learn English, Math, Anatomy and Computer. Year 2 and 3 students move to a small town in Bago Division Myanmar where their academic learning is supplemented with practical experience working alongside local and expatriate doctors at the T-RAD clinic operated by Earth Mission. Year 4 students are based in a very remote clinic in Karen State where they gain even more experience and then Year 5 students do an internship with the KDHW in their remote clinics.

Funds sent to this program in 2019 went towards the salaries of local clinic and teaching staff.

STORIES OF CHANGE

STORY ONE This little boy attends the preschool class of the CCM Project in Yangon. He has one brother and two sisters. His Dad works as a house painter and his mum makes things to sell at home. He was born with Downs Syndrome and there was no opportunity for him to attend a special school near the community where he lives. Two years ago the CCM team invited him to join



the preschool class. At that time he could not feed himself, dress himself, speak or tell anyone he was thirsty. Although it was a lot of extra work for the teachers he can now do all those things for himself and plays happily with the other children. His parents are so happy to see the improvements in his physical and emotional condition, and are extremely grateful that he has a chance to be a normal little boy by going to school, where he can learn and play.



STORY TWO This mother of three explains about her challenges

and how CCM has been helping her son. "My husband is in jail and I have to support my three children with some help from my mother and sister. I also had to have an operation which removed one of my kidneys and I had to borrow money for the medical fees. After the operation my health was not good and I could not carry heavy objects. But I had no choice and in order to support my children I went around the community selling watermelon. Due to my health I could not do this every day but when I did I could earn up to 3,000 kyats (\$3) AUD). Financially I have hardly anything – no property and a lack of money but my hope is to see my children educated. Due to my background this has been a challenge but with CCM this has given me hope for my five year old Kyaw Lyn Oo who has been attending CCM preschool for one and a half years. My son is not like before. Previously he walked on the street from dawn to dusk spending his time playing with bad people. However since coming to CCM he has changed his behavior and whenever he comes back from school he sings songs and plays nicely. He is really confident, bright and can remember what he is learning at school. I am really happy and grateful to CCM. For the future project, especially in this slum area, will help to keep our children safe as it can be a dangerous place."



STORY THREE

The baby in this photo is a very special little miracle. The staff at the T-RAD clinic walked an incredible journey with her parents to help make this miracle happen. Her mum had had 3 previous pregnancies that sadly all ended in miscarriage or still birth, and mum had almost given up hope of ever holding a healthy live baby. After being assessed by the doctors and midwifery team at T-RAD it was discovered that mum had a condition that, although easily treated in Australia, was not usually treated in Myanmar. The team set up a treatment protocol for her which included regular trips (accompanied by a health worker) to Yangon to visit an Obstetrician. Although it was planned that she would give birth in Yangon, she went into early labour at 35 weeks but the team was able to get her to the nearest hospital with specialist services. Finally this couple had a living, breathing baby in their arms. Baby did develop jaundice after returning home but the team were able to make sure she received the treatment needed.

What a journey! This precious little one is now happily at home with her doting and thankful parents; she is gaining weight and feeding well.



STORY FOUR Saw Moo Kler Taw - Year 4 (2019) Physician Assistant

student – "For Year 5, I am looking forward to learning more about: delivering babies, doing an ultrasound, reading and understanding electrocardiogram and performing lumbar puncture checks on patients on my own. I also want extensive understanding of diseases common in remote areas. When I first started as Year 1, I didn't have any real knowledge about diseases, medicines and patient care. I didn't know what a medical practitioner really does. Now, I know that I can literally save lives, and I can make patients feel better. I know more about diseases, medication and how to take care of patients."

FROM THE CHAIR

There is a great old hymn composed in 1820 that still remains popular in many places – "Abide with me" One of the great lines of the hymn is "change and decay in all around I see, help of the helpless O abide with me."

There is no doubt we have seen a lot of 'change and decay' over this last year in regards to Myanmar. Decay in the way in which Aung San Suu Kyi, the rewarded peace activist and critic of the military is now seen defending their human rights abuses, war crimes and genocidal actions towards the Rohingya people. This has been incredibly sad to watch, even as we try to understand the immense pressures on her. The unwillingness of the government to allow investigators in to follow up on accusations of evil actions speaks of their guilt in the ways they have dealt with their own citizens. Actually denying them citizenship makes it even worse. While there have been some positive steps by the government towards helping various states and groups within Myanmar, it is clear there is a long way to go on many fronts before basic human needs in terms of food, shelter and health are going to be met. Maternal and child mortality statistics are improving but only slowly and this is the key area of our work in training medics and midwives. Having received gifts that have made progress in that area possible and the purchase of sorely needed capital equipment a reality, we also need to turn our attention to how we help local people make it sustainable. That is going to be a growing part of our focus in the coming year.

In terms of change, this has been a year with much less change and stress in terms of our relationship with a parent body. As you know, in December 2018 our affiliation with the international partnership called Partners Relief & Development ended. Some of the key issues for us were around the transition between relief and development. Delays in moving people from straight relief (which is what is necessary for those internally displaced and those who flee to other countries to avoid genocide) to people doing what they can to support themselves even in extremely difficult situations is vital to prevent a kind of toxic relief that produces dependency. Of course, created dependency does have an upside - a feel good emotion for the donors - but it's very unhelpful in the long term. This is of particular importance to us because the long term Sustainable Development Goals (SDGs) which are a key focus area for us, for ACFID and for the Australian government. Additionally Partners Relief & Development was expanding their work into Syria and other conflict areas further away. Our Board did not feel comfortable with that given the huge human rights crisis in Myanmar and the growing one in West PNG with Indonesia, both far more important strategic areas for Australia. Separating from Partners as we have, and developing our own brand, has allowed the focus to remain on what we believe is the priority for us. Our new logo made its appearance early in the year and is getting more of a work out in various ways on banners, the web site and in reports. It is serving us well. We've upgraded our web site, with more change in that area yet to come, and we've still had a few problems with the technology of emails. However we are making progress with those issues as well, and overall the changes have been very positive. The new site offers much more ability in terms of not only messaging, but in getting supporters signed up as well.

We've changed in our fund raising too. We decided to give an all out effort for a period of time to raise funds on a much bigger scale. We were given a substantial bequest a year ago from a foundation that had been very generous over the years and, given our new independent status, the board felt it prudent to spend a portion of that money in trying to create a much bigger return. It's been difficult because this last year has seen the government continuing to slash overseas aid and encourage people to see only local issues. We believe this is a very short-sighted approach and have sought to do better by thinking wider and bigger. Its not a matter of trying to get a bigger slice of the same pie but rather making a bigger pie overall as everyone is educated into the benefits of global citizenship. The best we can say about our fund raising efforts to date is that we're trying hard; we've had great ideas with lots of effort for very little reward at this point. We expected this for a while anyway so it is not outside expectations. Some things we thought would be a relatively easy sell – especially with schools and churches have struggled because it is so hard to get in the door. We will continue to invest in this area to actually get income flowing in and more supporters.



We continue our journey with ACFID, the ACNC and the state authorities (who still require it) in terms of compliance. It was our year to do the full ACFID Code Self Assessment, which is a huge job for a small organisation like us, but we submitted it on time and are awaiting our results. During the year the ACNC introduced new regulations about the standards needed when sending money overseas, so we spent time making sure we have the procedures in place that comply with those standards. Joy, Eric and Brian have done a fantastic job in keeping up with the multiple demands in our policy and finance areas and the organisation owes them a debt of gratitude that is hard to express.

The three key projects, the midwife training and the physician assistant training, two programmes we run in partnership with Earth Mission Asia, and the Early Education project running in the slums in Yangon with Community Care Myanmar have all run well this year and achieved the goals set of them. We look to expand both in these partnerships this coming year. In 2020 we will also be forming a partnership with Love Conquers All to support two of their agriculture initiatives in Shan State.

So, a mixed year. Fund raising barriers, bad politics, not terribly good economics balanced with incredible staff, some great outcomes and some progress in supplying needs. It has been both hard and satisfying this last year. Two quotes I've used with the board this last year remind me about what we are on about as an organisation – what drives and motivates us. One from Pope Francis "You pray for the hungry. Then you feed them. That's how prayer works." The second from Jim Wallis – an American Evangelical leader: "The failure of political leaders to help uplift the poor will be judged a moral failure."

We don't intend to fail. We want to be seen on the right side of history as we move into the future having used the gifts and abilities we've been given to help the marginalised of Myanmar.

NOTE 1: Statement of Accounting Policies

This financial report is a special purpose report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act. The committee has determined that the Association is not a reporting entity and therefore there is no requirement to apply Accounting Standards and other mandatory professional reporting requirements (Urgent Issues Consensus Views) in the preparation and presentation of these statements.
